### **PUBLIC NOTICE OF HEARING ON THE APPLICATION OF EPCOR WATER ARIZONA INC. FOR APPROVAL OF A SYSTEM IMPROVEMENT BENEFITS MECHANISM FOR ITS ARIZONA WASTEWATER DISTRICT. (DOCKET NO. WS-01303A-16-0145)**

### **SUMMARY**

EPCOR requests approval of a System Improvement Benefits (“SIB”) mechanism for its Arizona Wastewater District, to recover a return on and of net investments made between rate cases for pipe and manhole replacement and rehabilitation in its Sun City and Sun City West service area collection systems.

EPCOR plans to complete the projects over a five-year timeframe to control costs and reduce rate shock and estimates the following annual costs by wastewater service area:

EPCOR proposes for its SIB mechanism to include: (1) filing of financial statements and an earnings test schedule; (2) a 5-percent surcharge efficiency credit; (3) reconciliation and true-up; (4) a 5-percent annual cap on the revenue requirement; (5) no more than 5 SIB surcharge requests between rate cases; and (6) other protections detailed in the proposed plan of administration included with the Application.

EPCOR estimates that the monthly surcharge amount per customer for each customer class will be as follows:

### **Arizona Corporation Commission Public Hearing Information**

The Commission will hold a hearing on this matter beginning **April 30, 2018, at 10:00 a.m.**, at the Commission's offices, 1200 West Washington Street, Phoenix, Arizona. Public comments will be taken on the first day of the hearing.

Written public comments may be submitted by mailing a letter referencing Docket No. **WS-01303A-16-0145** to Arizona Corporation Commission, Consumer Services Section, 1200 West Washington, Phoenix, AZ 85007, or by submitting comments on the Commission's website ([www.azcc.gov](http://www.azcc.gov)) using "I Want To" and "Submit a Public Comment." **If you do not intervene in this proceeding, you will receive no further notice of the proceedings in this docket. However, all documents filed in this docket are available online** (usually within 24 hours after docketing) at the Commission's website ([www.azcc.gov](http://www.azcc.gov)) using the e-Docket function. **Parties who intervened in the first phase of this matter remain parties in this second phase.**

### **About Intervention**

The law provides for an open public hearing at which, under appropriate circumstances, interested persons may intervene. An interested person may be granted intervention if the outcome of the case will directly and substantially impact the person, and the person's intervention will not unduly broaden the issues in the case. Intervention, among other things, entitles a party to present sworn evidence at hearing and to cross-examine other parties' witnesses. However, failure to intervene will not preclude any interested person or entity from appearing at the hearing and providing public comment on the application or from filing written comments in the record of the case.

To request intervention, you must file an **original and 13 hard copies** of written request to intervene with Docket Control, 1200 West Washington, Phoenix, AZ 85007, **no later than March 19, 2018**. You also **must** serve a copy of the request to intervene on each party of record, on the same day that you file the request to intervene with the Commission. Information about intervention and sample intervention requests are available on the Commission's website ([www.azcc.gov](http://www.azcc.gov)) using "I Want To" and "Learn about Intervention in a Utility Case" and "Intervene in a Utility Case."

Your request to intervene must contain the following:

1. Your name, address, and telephone number, and the name, address, and telephone number of any person upon whom service of documents is to be made, if not yourself;
2. A reference to **Docket No. WS-01303A-16-0145**;
3. A short statement explaining:
  - a. Your interest in the proceeding (e.g., a customer of EPCOR, etc.),
  - b. How you will be directly and substantially affected by the outcome of the case, and
  - c. Why your intervention will not unduly broaden the issues in the case;
4. A statement certifying that you have served a copy of the request to intervene on EPCOR or its attorney and all other parties of record in the case; and
5. If you are not represented by an attorney who is an active member of the Arizona State Bar, and you are not representing yourself as an individual, sufficient information and any appropriate documentation to demonstrate compliance with Arizona Supreme Court Rules 31, 38, 39, and 42, as applicable.

The granting of motions to intervene shall be governed by A.A.C. R14-3-105, except that all motions to intervene must be filed on or before **March 19, 2018**.
