CUSTOMER NOTICE OF INTERIM RATE ADJUSTMENT

Pursuant to Texas Utilities Code Section 104.301, EPCOR Gas Texas Inc. (the "Company"), filed an application for an Interim Rate Adjustment with the City of Magnolia ("City") on July 3, 2024. This proposed Interim Rate Adjustment applies to 2023 and provides for the recovery of additional capital investment incurred from January 1, 2023 through December 31, 2023. The request is for capital investment not included in any previous rate case or rates for service and is subject to refund.

On October 7, 2024, the Company filed a revised application that was necessary to reflect the required rate design allocations and include adjustments that were noted during a review of the application.

The Company proposes to increase the customer charge used to calculate the customer's monthly bill by the amounts listed below. The proposed Interim Rate Adjustment effective date is November 19, 2024.
