AN UPDATE ON COPPER BASIN

The new Copper Basin Water Reclamation Facility will start operating this December. It will be fully enclosed with state-of-the-art odor control equipment and extensive systems to monitor conditions around the clock. When complete, Copper Basin is expected to serve 14,000 San Tan wastewater customers and add 1 billion gallons of reliable, clean water annually into the natural water cycle.
