SUBJECT: Water Main Cost Sharing Program – 2025 Rebates

This memorandum is intended to provide updated EPCOR rebates for the Water Main Cost Sharing program. The rebates in this memorandum apply to projects with a construction start date between January 1, 2025 and December 31, 2025.

* Effective 2008, Goods and Services Tax (GST) will not be included in the lineal cost of pipe. GST will be added separately to the total approved amount of rebate for each application.

EPCOR's Water Main Cost Sharing Program Application Procedures

1. Companies eligible for the Water Main Cost Sharing Program must apply using Sheet B of the As-built Quantities and Costs Report in the CCC Application Package. One application is required for each phase of a project within a specific land servicing agreement. The application must be signed and sealed by the Project Engineer. The As-built Quantities and Costs Report can be obtained on EPCOR's web site www.epcor.com or by contacting the following:

The following supporting documents must be included with a completed Sheet B of the As-built Quantities and Costs Report and submitted via ProjectDox with the complete CCC Application Package:

- ☐ An 11x17 overall water main plan highlighting which mains are included in the rebate application,
 - ☐ One copy of the Progress Payment Certificate indicating pipe diameters, lengths, and pressure classes.
2. Upon receipt of the application, EPCOR will verify the applicant's eligibility for the Water Main Cost Sharing Program as well as the applied-for rebate amount. In addition, the supporting documentation will be verified to ensure it is complete and to the satisfaction of EPCOR. EPCOR makes all payments via direct deposit. Please request and complete the EFT (Electronic Funds Transfer) form by contacting accounts_payable@epcor.com in order to receive payments from EPCOR electronically. The payment will be processed based on the CCC Approval Date, as signed by the City Planning and Development representative.
