EPCOR Natural Gas Limited Partnership has also applied for approval of natural gas franchise agreements and certificates of public convenience and necessity that will permit it to distribute natural gas and construct and operate the proposed facilities.

In 2018, the Ontario Energy Board selected EPCOR Southern Bruce Gas Inc., an affiliate of EPCOR Natural Gas Limited Partnership, as the successful proponent to expand natural gas service to communities within the municipalities of Arran-Elderslie and Kincardine and the Township of Huron-Kinloss, that currently do not have access to natural gas service.


EPCOR Natural Gas Limited Partnership has applied to the Ontario Energy Board for approval:

- To construct 298 kilometres of natural gas pipeline needed to supply natural gas to communities within the municipalities of Arran-Elderslie and Kincardine and the Township of Huron-Kinloss that currently do not have access to natural gas service
- Of the form of agreement it offers to landowners to use their land for routing of the proposed natural gas pipeline
- Of a natural gas franchise agreement with the municipalities of Arran-Elderslie, Kincardine and the Township of Huron-Kinloss and an order that the agreement of the municipal voters in each of the municipalities is not required in relation to granting the natural gas franchise agreement. The natural gas franchise agreements grant EPCOR Natural Gas Limited Partnership the right to construct and operate works for the distribution, transmission and storage of natural gas and the right to extend and add to the works for a period of 20 years within the municipalities
- Of franchise agreements with, and the issuance of limited certificates of public convenience and necessity for which will authorize the distribution system and works to pass through the following municipalities: County of Bruce, County of Grey, Municipality of Brockton, Municipality of West Grey and Township of Chatsworth. For the franchise agreements, an order that the agreement of the municipal voters in each of the municipalities is not required in relation to granting the natural gas franchise agreement

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider the application filed by EPCOR Natural Gas Limited Partnership. During the hearing, we will question EPCOR Natural Gas Limited Partnership on the case. We will also hear questions and arguments from individuals, municipalities and others whose interests would be affected. At the end of this hearing, the OEB will decide whether to approve the application.



As part of its review of the application to construct the proposed facilities, the OEB will assess EPCOR Natural Gas Limited Partnership's compliance with the OEB's Environmental Guidelines for the Location, Construction and Operation of Hydrocarbon Pipelines and Facilities in Ontario.

The OEB advises Indigenous communities that the OEB's process for this application may serve as a component of the Crown's duty to consult for this project.
